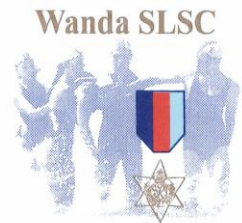

Re Great News about the Club Re-Opening and Expectation on Members

Club Facilities Re-Opening from 11 October & What Members Need to Observe

On 11th October 2021, in accordance with the NSW Public Health Order, Wanda SLSC's facilities will re-open, and we will see additional numbers Patrolling, the commencement of face-to-face Education Programs and greater numbers participating in competition training. We will see the opening of the changerooms/amenities, gym facilities, gear shed, and downstairs training room. For this to happen we require all members to observe Public Health Order rules - specifically; mask wearing, 4sqm rules, QR Code checking and vaccination policy.

Vaccination Requirements

All Patrolling Members, Competitors in training, Trainers, Assessors, Facilitators, Age Managers and Water Safety Members and those interacting with and in groups, participating in teams or those who use any of the Club's facilities such as the Club Gym, who are eligible to be safely vaccinated must be **doubly vaccinated**, unless they are exempt on medical or other grounds. On 1st December 2021, this Policy will be reviewed in line with the NSW Public Health Orders made at the time.

Proof of Vaccination

We encourage all members to provide proof of vaccination before engaging in any club-based activity. You can do this by sending a valid vaccination certificate to clubhouse@wandaslsc.com.au we also ask that you ensure you have your proof of vaccination Certificate on you if this needs to be validated whilst visiting the club or participating in club activities.

Club Gym

Gym members wishing to use the club facility during this period will have their fobs activated once their proof of vaccination has been validated and recorded by the club office.

Requirements by Members during the Government's 70% to 80% Vaccination Phase

The attachment provides additional detail about each area and the unique requirements. I request members' support by following the requirements so that we reduce risk to member's health and ensure we do not put individuals and the club at risk financially through noncompliance.

In summary, if you are looking to visit the club during the government's 70 and 80% vaccination phase you will need to:

1. Be a financial member of the Club.
2. Be vaccinated (having received 2nd vaccination).
3. Register using the QR code system.
4. Wear a mask.
5. Follow the capacity limits for indoor areas.
